- 1. The above prices provide free breakfast based on the number of guests and booked room type.
- 2. Bill payments incur bank or remittance fees plus fees, which are paid by the guest.
- 3. Free wireless Internet access is provided in the guest rooms.
- 4. In compliance with the Smoking Prevention and Control Law, smoking is prohibited in the hotel.
- 5. In order to maintain the quality of the housing, pets are not allowed in the hotel. If a pet is found, a cleaning fee of TWD \$3,000 will be charged.
- 6. If the facilities in the room are damaged or lost, compensation will be charged according to the market price.

Cancellation and deposit refund standard:

- 1. For group reservations, 30% of the total room fee must be paid within 7 days from the date of placing the reservation. If the deposit is not paid within the time limit, the hotel has the right to cancel the reservation after notification.
- 2. The deposit can be paid by remittance or credit card, and the balance must be paid 7 days before the guest's check-in.
- 3. Once the reservation is completed, if the check-in is not possible as scheduled due to force majeure factors such as natural disasters or man-made disasters and the hotel
- is required to request a refund, the hotel has the right to charge fees according to the following standards:
 - I. If the cancellation is made 31 days before the accommodation date, the hotel shall refund 100% of the total room fee. II. If the cancellation is made 21 days before the accommodation date, the hotel shall refund 80% of the total room fee.
 - III. If canceled 14 days before the accommodation date, the hotel shall refund 50% of the total room fee.
 - IV. If the cancellation is made 3 days before the accommodation date, the hotel shall refund 30% of the total room fee.
 - V. If you cancel on the day of stay, the hotel will not refund the total room fee.
- 4. If the guest NO-SHOW on the day of stay, the hotel will charge the first night's room rate and the room will not be reserved.
